By requesting space, the undersigned, hereinafter referred to as *Exhibitor*, hereby applies for participation in NPE2027: The Plastics Show owned & produced by the Plastics Industry Association, hereinafter referred to as *PLASTICS and/or Show Management/Management*.

**License Relationship.** It is understood and agreed that this Contract constitutes a non-assignable license and privilege only and is not, under any circumstances, intended to constitute a lease or any other conveyance of real property, a partnership, employment agreement, or joint venture between the parties.

**Right to Offset.** Management shall have the right to offset the amount of any obligation due and owing to Management from Exhibitor whether under this agreement or any other agreement between Management and Exhibitor. Management may cancel the Exhibitor's participation in NPE2027 in the event that Exhibitor is past due on any amount due to Management for any reason.

Space Assignment and Attendees. Although Management will attempt to accommodate Exhibitor requests for specific booths, no guarantee can be made that Exhibitor will be assigned the specific booth(s) requested. Exhibitor acknowledges that it is not contracting for a specific booth(s), but rather for the right to participate as an exhibitor in NPE2027. Management will assign space, and may reassign the space, or alter the space layout or venue at any time in its sole discretion. Management makes no representations or warranties with respect to the demographic nature and/or number of exhibitors and/or attendees.

Upon acceptance by Management, Exhibitor hereby acknowledges reading and understanding the <a href="NPE2027 Show Rules & Regulations">NPE2027 Show Rules & Regulations</a>. Exhibitor understands and agrees that the show rules and regulations ("Rules") are an integral and binding part of the exhibit space contract ("Contract"). Exhibitor, on behalf of themselves and their employees, agree to abide by all rules and any appendices or addendums, including those previously issued and any updates and/or correspondence outlining revised and new policies, which may be issued at any time at the discretion of NPE Show Management. Without limitation, Exhibitor will be bound by all rules and regulations outlined, including any Appendices, and payment terms.

Failure to comply with the NPE Show Rules & Regulations and the Terms & Conditions set forth in this Exhibit Space Application may result in any or all of the following liabilities and consequences:

- 1. Loss of Show History for the current show cycle.
- 2. Immediate removal of exhibitor and booth from show, at exhibitor expense.
- 3. Payment of monetary damages, fees & costs, arising out of violation(s) per the NPE Show Rules & Regulations, as determined by Show Management.
- 4. Denial of exhibition & sponsorship opportunities in future show cycle(s).
